- 5. Please login to <u>www.tenantev.com</u>, to pay a non-refundable \$100 application fee (per person over age 18) and fill out the application online. Acceptance of the processing fee does not in any way constitute approval of this transaction.
- 6. The complete application must be submitted to the Alta Mar Office at least 15 days prior to the desired date of occupancy (start date of the lease)
- 7. New or returning renters will pay \$50 per applicant and new buyers will pay \$50 for processing the transfer of title. These fees must be made payable to Alta Mar and will help defray the costs of processing all of the required paperwork for sales and leases as well as for orienting new owners and new/returning renters.
